1. President's Report

The CRCC has enjoyed another successful season over the past 12 months both on and off the water. Our membership has continued to grow with total membership for the year reaching 111. Our membership was 93 last year and 76 the year before that. Of the 111 members 46 were new members, excluding volunteers.

The Club's finances are in good shape (refer to Finance Report) with our end of financial year (end of June 13) account balance being \$24,895 up from \$20,042 at the end of last year. These accounts have been audited by club member Mike Galanty.

A significant milestone for the year has been the securing, after long negotiation, a three year lease for a boat storage facility at Kent Street Weir. This facility was formally the Chilean Soccer Club and with a little bit of work we believe will make a good interim boat storage facility while we continue to search for a long term home. It is the club's intention to continue to operate our Tuesday night races from Riverton Bridge, but we will trial some Summer races from Kent Street Weir. We will also run our junior squad training from Kent

Street Weir. I would like to specifically acknowledge Dave Brown's efforts in getting this facility over the line and continuing to put in a lot of hours in getting the facility functional. Others who I would also like to acknowledge are Mark Stillman for assisting with the electrical work and also Christian Thompson for his input over many, many years in pursuing such a facility for the club. I should point out that there are certain members of the community who are opposed to us taking up this lease and it will be incumbent on all members to ensure we continue to respect the river and its environment.

On the water many of our members have continued to succeed in paddling events outside the club events at a local, national and world stage. I was going to acknowledge these achievements individually, but when I started to compile them there were so many that I will wait until our end of season awards lunch next month.

The club has also had a number of its members undergo various forms of training over the past year including Coaching, Officiating and First Aid. This is an important part of our club's development and we hope to continue this over the next 12 months.

Club events

We have continued to run two main events being the Canning Classic and the Canning Nomination. Both events continue to be well attended and contribute significantly to our annual fundraising and we will therefore continue to run these events during the next season.

Training Squad

During the past year we have commenced a semi-regular Saturday afternoon training squad. This squad was established with the specific intent to train members in all aspects of paddling including technique, racing skills and general fitness. Thank you to Dave Brown and Ken Ringrose who have been an integral part of this program. Our intention is to continue this session over the coming year.

Come and Try

This year we have instigated an Come and Try program by appointment. Dave Brown has run this and introduced a number of people to paddling, many of which have gone on to become Members.

Volunteers

Although it goes without saying that our club cannot run without the overwhelming generous donation of time by volunteers. I have to say that our volunteers are second to none and truly go above and beyond just doing the bare minimum to keep a club running. Our club has continued to grow over the past year, our successes have been significant and all of this has been as a direct result of our volunteers. While there are too many to name here I would like to specifically acknowledge the work done by our committee over the past year. It have been a pleasure to work along side them and be inspired by their commitment

to the club week after week. We will celebrate the work done by our volunteers at next month's award lunch.

In summing up, I am looking forward to the next 12 months and being part of a club that I'm sure will continue to thrive and develop from the work done over the last 12 months.

- Add detail for requirements of affiliation with "Canoeing Western Australia Inc."
