## 1. President's Report

Well another year has come and gone and I'm pleased to say that the Canning River Canoe Club (CRCC) continues to provide great services to our members and the community as a whole. Our membership continues to float between 70 and 100 paddlers.

This year I haven't included a membership breakdown because we have recently moved to a new membership system and I have no access to last years membership details.

The club continues to enjoy a sound financial position (Refer to accounts attached). In accordance with our constitution these accounts have just been audited with positive results. Our books continue to be managed by our Treasurer using MYOB Account Right software which is a cloud based package. Our cash flow has grown from last year and now sits at around \$26,000 up from \$20,000. This growth has come from additional income and grant contributions with the club making a small profit over the year after paying for our boat shed facilities cost.

Our objective is to continue to increase the club revenue stream to at least break-even for the Boat shed annually. We continue our long-term relationship with Shelley Sailing club to operate out of their premise during the winter months. The relationship between the sailing club and CRCC is clearly working well with benefits to the Sailing club of a winter presence and a winter income stream. This is also looked on very favourably by the Canning City who are keen to encourage co-share facilities.

In regard to clubhouse facilities the committee has worked with the City to try and establish a commitment from the City that would guarantee our long-term premise. This is work in progress, suffice to say the City understands our needs and we will continue to ensure that future redevelopment work by the City at Kent Street is cognisant to our needs.

The Club Committee worked with the city and its strategic vendor to refresh the CRCC strategic plan. This involved participation in 5 evening workshops over August, although demanding, this was another way of ensuring the City sees us as meeting their requirements when future club needs are determined. A big thankyou to club members David Brown and David Griffiths for pulling the final documents together.

Our relationship with River Fury Dragon Boaters continues, they are active users of the facilities but have not impacted our operations.

On the water many of our members have continued to succeed in paddling events outside the club events and these were acknowledged at our awards presentation lunch which was our most successful to-date. The event was held at the CRREC environmental centre at Kent Street and the place was decked out brilliantly by our volunteer ladies. A big thankyou to David Griffiths and Simone Burge who were largely responsible for the venue and catering.

#### **Club events**

We have continued to run two main events being the Canning Classic and the Canning Nomination. Both events were run well and contribute significantly to our annual fundraising and we will therefore continue to run these events during the next season. We raised a little over \$1400 from our two events plus and from catering at the Northam to Toodyay race.

### **Training Squad**

We have maintained the Kent Street Saturday morning training squad program over the past year. A big thank you to the coach Jerry Alderson, who runs the Saturday morning sessions over the year.

#### Come and Try

Come and try sessions are now available on a booking basis by contacting Dave Brown, Judith or Simone, details are on the website. Dave Brown has reinvigorated the come try club solution and we congratulate his efforts which are resulting in increased memberships.

### Volunteers

Volunteers continue to be the lifeblood of our club and I would like to thank everyone who contributed to the club over the past year. Whether it is done week in and week out, or simply as a one off – all contributions are greatly appreciated. Again, we will acknowledged the efforts of our volunteers at our awards presentation lunch.
